MINUTES

1. Call to order and declaration of a quorum present.

Mayor Cox called the meeting to order and declared a quorum to be present at 6:00 p.m.

2. Roll Call.

3. Pledge of Allegiance.

Mayor Cox led the Pledge of Allegiance.

Mr. Bunn offered the invocation.

4. Welcome.

Mayor Cox welcomed guests.

5. Discussion of Agenda items.

Mayor Cox called for any discussion of agenda. There was no discussion.

6. Approve the Consent Agenda:

7. Consideration and possible action on items removed from the Consent Agenda.

8. Presentation and discussion of the Treasurer's Financial Report.

Mr. Bunn gave the following Financial Report for the month of May 2019.

- Sales Tax for the month of May versus a year ago is down, however it is up Year-to-Date
- Use Tax is up for both the May 2019 and Year-to-Date.
- Tobacco Tax and Excise Tax are both down.
- Electric sales are down due to mild weather but overall Year-to-Date is up.
- Water sales are significantly down due to excessive rain over recent months.
- Public Works revenue/expense variance is negative but Year-to-Date variance is up.
- General Fund variance is negative.

9. Presentation and discussion of the City Manager Report.

Mr. Bunn reported on the following:

- The Purcell/Lexington Bridge is scheduled to be completed sometime in July but the exact date has not been announced.
- At the Multipurpose Center the sidewalks have been poured between Basketball Courts and all of the cement has been poured.
- Last month we had three projects that received no bids. The MPC Roof and Water Damage Repair and Purcell Trails Phase 1, are out for rebid. Both open in July. The HVAC was let out for rebid at this time.
- The Department of Tourism has awarded the City a \$240,000 grant for the Lake Trails Phase 2 Project, contingent upon Phase 1, being completed.
- 10. Discussion and possible action concerning Ordinance No. 19-06 AN ORDINANCE ESTABLISHING AND IMPLEMENTING A PROGRAM TO CHARGE MITIGATION RATES FOR THE DEPLOYMENT OF EMERGENCY AND NON-EMERGENCY SERVICES RENDERED BY THE CITY OF PURCELL FIRE DEPARTMENT; PROVIDING FOR MITIGATION RATES AND INCREASES THERETO; PROVIDING FOR AN EFFECTIVE DATE; AND PROVIDING FOR REPEALER.

Fire Chief Greg Cypert advised this ordinance is not meant to be a revenue generating venue, but rather, an attempt to recover cost. Many times interstate emergencies and non-emergencies tie up hours of Fire Department personnel, time and equipment. The Fire Department has contacted a billing and collection company willing to handle both billing and collection on our behalf. The ordinance allows us to be able to work with them in cost recovery. We are required to provide them with at run report and they take it from there. He advised citizens of Purcell are not meant be effected by the ordinance, it is mainly geared for interstate runs.

Councilman Jacobs made a motion second by Councilman Engert to approve Ordinance 19-06 as written.

Councilman Jacobs made a motion second by Councilman Tate to approve the recommendation from the Senior Board to reappoint Karla Brakefield and Valerye Haley for two year terms.

13. Discussion and possible action to declare 304 W Delaware Street a dilapidated structure.

Teddy Boles informed the Council that this item was table in a previous meeting, and since, is under new ownership. The new owner is fixing the property up for resale or rental.. Mr. Boles

made the recommendation to table this matter to the September meeting. The request was to allow Code Enforcement to work with property owners, yet keeps it in the active status.

Councilman Tate made a motion second by Councilman Engert to table 304 W Delaware Street to the September 3, 2019 meeting.

Mr. Boles advised this property has just come out of probate and there are two potential buyers. The mowing is being kept up on the property. Chief Williams stated the house was not secure last week. Mayor/Chairman Cox declared no action for Executive Session item.

21. City Council comments.

Councilman/Trustee Tate addressed Mr. Bunn regarding the Citizens Claim Tracker not working properly on the City Website. Mr. Bunn acknowledge the problem and advised he has contacted the Web-administer. He also asked to see all test results on the swimming beach. Mr. Bunn replied that the Ecoli count was 172 and DEQ recommends no more than 100, although there is no legal limit. Mr. Bunn advised we are beginning to conduct tests on a weekly bases. Prior to this it was being done every couple of weeks because we never had a fail and it saved the City money.

Councilwoman/Trustee Engert asked if there will be benches at the Basketball Courts for spectators.

Councilman/Trustee Fishburn commented that no one is happy about high bacteria count. Upon driving by he advised there are so many geese that they are becoming a nuisance and may be the source of Ecoli.

Councilman/Trustee Jacobs stated on the south end of the Basketball Courts at McCurdy, the concrete is broken off and caved in. On the east side it is chipped out and then further east is the spot that was previously reported. Councilman Jacobs reported he has concerns that what was previously reported will cave in as well. On the northwest corner side they cut the concrete and it is still open. Water is infiltrating and getting under the concrete. Mr. Bunn reported the City will do a walk through and will not be accepted if not acceptable done. Councilman Jacobs reported the nets are not installed correctly and one doesn't have a net at all.

Mayor/Chairman Cox asked the question if hiring a contractor to put up and taking down Christmas lights had ever been checked out. The reason for the request is our Street Department is so tied up and are not able to do other projects. Mayor Cox also stated that it had been brought to his attention that properties such as the River View Lot, that the City has to maintain since no one owns it and the City has to maintain. He asked it there a way of declaring it as surplus and possible selling it. One other concern that was brought to his attention is the GreenScape project since it is overrun with weeds and dead plants. Councilman/Trustee Tate asked about volunteers to adopt areas. Mr. Bunn advised it was a safety concern.

22. City Manager and staff comments.

Chief Williams advised he believed the Purcell Lake is a national bird sanctuary.
