

RESOLUTION NO. 19-C15

A RESOLUTION OF THE CITY COUNCIL, OF THE CITY OF PURCELL, OKLAHOMA AMENDING SECTION 4, SECTIONS 8, AND SECTION 9 OF RESOLUTION NO 14-C01 ESTABLISHING CEMETERY FEES, CHARGES, AND ASSESSMENTS FOR HILLSIDE CEMETERY, PURCELL, McCLAIN COUNTY, OKLAHOMA.

WHEREAS, the City of Purcell is charged with the duty of establishing fees, charges, and assessments for Hillside Cemetery, located within the corporate limits of the City of Purcell, McClain County, Oklahoma; and,

WHEREAS, the Purcell Cemetery Board in a regular meeting September 18, 2019 voted to make the recommendation to the Purcell City Council, to increase certain above of the stated fees; and

WHEREAS, the Purcell City Council deems it necessary and in the best interest of the City of Purcell to increase fees, charges and assessments for Hillside Cemetery, Purcell, McClain County, Oklahoma;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PURCELL, OKLAHOMA THAT:

Section 1. From and after the adoption of this Resolution, Monument Setting Permit Fee for Hillside Cemetery will be as follows:

MONUMENT SETTING PERMIT FEE

Monument Set Permit	\$ 20.00 per space
Government Markers	\$ 0.00 per space

Section 2. From and after the adoption of this Resolution, the Cemetery Space fee charges and assessments for Hillside Cemetery will be as follows:

CEMETERY SPACE FEE:

East of Gate	\$600.00 per space
First 10 rows west of gate	\$700.00 per space
Remaining west of gate	\$800.00 per space
Babyland	\$200.00 per space
Veterans in Veteran's Section (with proof of an Honorable Discharge) (Opening and closing fees apply to Veteran Spaces)	\$ 0.00 per space

Section 3. From and after the adoption of this Resolution, the Grave Opening and Closing fee, charges and assessments for Hillside Cemetery will be as follows:

GRAVE OPENING FEES:

REGULAR HOURS


Adult	\$650.00
Cremation (Family open and close)	\$ 20.00 (Permit Fee Only)
Cremations (City open and close)	\$ 50.00
Child, (Defined as maximum 4ft)	\$ 50.00
